**Membership Terms and Conditions**

- I certify that I am at least 21 years of age and acknowledge that someone 21 years or older must be present for wine shipments. As a member you agree to all the membership terms and conditions.
- I authorize Arrington Vineyards & Winery to charge my credit card, plus tax and shipping for each club order shipment, if applicable. I understand that my credit card will be charged prior to shipment of wine.
- I understand that under Visa, Mastercard, Discover or AMEX terms and conditions, my credit may be automatically updated in Arrington Vineyards system.
- I understand that if I choose not to customize my wine selection or fail to do so before the deadline, I will be charged and shipped the winemaker's selection wines. All club sales are final and account updates submitted after your order has been processed will not be accepted. By law, we cannot accept returns on alcoholic beverages once they leave AV property (unless corked or flawed).
- I understand that after two club shipments, I may cancel my membership and that all cancellations must be received two weeks prior to the next selection. Any memberships canceled after the processing of a club order, will incur the regular fee for that month's order and cancellation will be effective for the next wine order. **Early cancellations are subject to a \$50 admin fee automatically charged to the card on your account.**

- I understand that orders held for pick-up will be automatically shipped after 30 days to the address on file. **\*\*If you miss picking up 2 club orders your account will automatically be switched to shipping for all future orders\*\***
- I understand that I am responsible for all costs incurred if my wine is returned to Arrington Vineyards, including reshipping, address correction or reprocessing fee.
- I understand Arrington Vineyards cannot guarantee the availability of a purchased vintage when a shipment is not picked up or received after 30 days of the billing date. Wines from a shipment may not be traded for other selections.
- **Shipping Policies:**  
Any person unable to provide age verification will forfeit their right to receive the shipment until identification is produced. All associated costs will be the responsibility of, and be charged to the member credit card on file. No deliveries can be mailed to a P.O. Box. Due to the restrictions of many state laws, Arrington Vineyards only ships wine to those states where direct shipment is permitted by law. In addition, some states impose limitations on the amount of wine that a resident of that state may receive.
- Membership is non-transferable. Arrington Vineyards reserves the right to change or amend the wine club at any time. Arrington Vineyards reserves the right to suspend or terminate memberships at any time. Termination of membership will disqualify you from membership benefits and future wine club participation.
